

- A. Welcome Guest: Paul Bigford was introduced welcomed everyone to the 48th annual banquet of the PMWC. Paul presented the Excellence in Conservation award to Pete DeBoer
- B. Mike Hoag asked for a moment of silence to honor the passing of John Towsley. John was a long-time friend of the PMWC who supported the river and was involved with all aspects of wildlife and habitat management. John and his family had participated in the first C4C and continued supporting the fund-raising event for 23 consecutive years.
